- California Quality Rating and Improvement System (CA-QRIS) – The CA-QRIS Consortium and QRIS efforts throughout the state were discussed. CA-QRIS adopted a new name: Quality Counts California.

- Consortia Engagement Process – F5CA has been involved in an intensive consortia engagement process, including coaching training and certification, family engagement training, and trainer approval.
- QRIS Common Data File – The Common Data File upload was successful. Initial statistics for this month were discussed. The Committee for the Protection of Human Subjects approved the addition of the California Department of Education as a formal partner under the existing evaluation protocol governing the Common Data File.
- End of the Legislative Session – Ms. Maben attended a signing ceremony with Governor Brown and the Legislative Women’s Caucus. The Governor signed SB 63 (Jackson), the bill F5CA sponsored. F5CA will continue with federal advocacy and moving the policy agenda forward.
